## Extract from Statutory Instrument

2 Inspection, testing, maintenance and repair of equipment and vehicles including the re-charging of compressed air cylinders and breathing apparatus	The person(s) who requests the service or to whom the service is provided
3 Containment and clearance of debris, spillages, discharges or leaks from a vehicle, storage tank or pipe	The owner(s), occupier(s) or operator(s) of any premises in relation to which the service is provided or the person(s) who requests the service or to whom the service is provided.
4 Provision or removal of water	The owner(s), occupier(s) or operator(s) of any premises in relation to which the service is provided or the person(s) who requests the service or to whom the service is provided.
5 Effecting entry to, or egress from premises	The owner(s), occupier(s) or operator(s) of any premises in relation to which the service is provided or the person(s) who requests the service or to whom the service is provided.
